RE: Informal Conference of February 10, 2026

Pursuant to a Staff Notice issued on February 6, 2025, an informal conference (IC) was conducted on February 10, 2026. Attached is a copy of the attendance roster.

The purpose of the IC was to discuss Rattlesnake Ridge Water District's (Rattlesnake Ridge District) water loss surcharge, the process to request expending funds from the water loss surcharge account, and to receive a status update as to Rattlesnake Ridge District's investigation case. Staff stated before the meeting that Staff could not speak for the Commission and that no decisions would be made during the meeting.

Rattlesnake Ridge inquired as to how to use the surcharge funds. Staff informed the district that it would need to file a motion requesting to use funds, specifically state the purpose, provide any quotes or bids, and state how it relates to its qualified infrastructure improvement plan. Staff reminded the district that Commission approval should be obtained before any purchases are made.

There being no further discussion, the IC was then adjourned.
