Dear Ms. Bridewell:

After receiving a letter from Kentucky Electric Power, providing notice of a proposed construction of an electric transmission line, this letter serves notice, of intervention I'm requesting by the Kentucky Public Service Commission. I'm a Seventy Two year old, senior citizen that has health problems and has been disabled since 1997. I'm requesting additional assistance from your office, submitting to you, the aforementioned information.

Arbitrary and Capricious decisions by Kentucky Electric Power:

1) Kentucky Electric Power, "**has never surveyed**" my property.

- 2) K.E.P., submitted a map, where it transmission lines go entirely out of the way, to take in 2 millionaire properties, for their Political contributions...(I will be making, Ky. Open Requests, to your office) for this information, to share with "Media outlets".
- 3) There is an "**Endangered Species**"...namely the "**INDIANA BAT**", living on my property, which will be disturbed. An additional letter, is being sent to the "Ky. Attorney General Office", "**Office Of Civil and Environment Law**", to intervene in the proposed route. Additionally, (KRS 15.255) Authorize the Atty. Gen. Office to bring legal action to prevent or remedy damage to the environment and to counsel state agencies and **commissions in environmental matters**.
- 4) A "**Historical Artifact**", is in the way of the proposed route. This artifact, is well known as the "**DANIEL BOONE ROCK**". This is documented by Kentucky Historical Society, Morehead State Archives and Floyd County Times Archives. Carved on the Rock: Initials of Daniel Boone and year 1775. (Exhibit No.1)
- 5) On property I own, "Diversified Gas Co.", has an (8" inch) natural gas "Transmission Line", laying on top of the ground. "Unbelievable, K.E.P., didn't reveal this to the KPSC!!
- 6) I paid thousands of dollars, to have (2 PONDS) built with fish stocked, that would have "irreparable damage" to them. Major Investment. Silt drainage is directly above these pond!!!!
- 7)Due to my Health Conditions, I'm advising you, of the **negative effects** from the Electromagnetic Radiation, this would have on my families health.
