Pursuant to Order issued on March 2, 2022, an informal conference (IC) was conducted on March 4, 2022. Attached is a copy of the attendance roster.

The purpose of the IC was to discuss the legal standard for “need” established by KRS 278.020 and KRS 278.5464 to grant a Certificate of Public Convenience and Necessity (CPCN) for a fiber optic network for distribution cooperatives. Commission Staff discussed the purpose of the IC was to ensure the record was complete in this case. Kenergy intends to file a motion for an extension of time to respond to the data requests submitted with the March 2, 2022 Order, and will work with the parties to find a date that is acceptable to all parties.
