INTRA-AGENCY MEMORANDUM

RE: Informal Conference of March 16, 2022

Pursuant to Staff Notice issued on March 14, 2022, a virtual informal conference (IC) was conducted on March 16, 2022. Attached is a copy of the attendance roster.

The purpose of the IC was for Commission Staff to provide guidance regarding what documents and information has been requested to analyze the rates.

Commission Staff, Justin Young, began the meeting by advising representatives of the City of Carlisle (Carlisle), Nicholas County Water District, and Sharpsburg Water District that notes would be taken during the conference and that Commission Staff would prepare and enter into the record a memorandum regarding the conference. Commission Staff further advised that the parties have five days after the memorandum is entered into the record to file comments on the memorandum.

Ariel Miller, Commission Staff, explained what outstanding information was needed for staff to make a recommendation to the Commission concerning the proposed wholesale rates of the City of Carlisle. Mr. Watson stated he was meeting with the City of Carlisle the day after the informal conference and was hopeful to have the remaining information tendered by Friday. There was general discussion about what outside resources the City of Carlisle could avail themselves of in an emergency, as well as some procedural conversation about how the case may proceed. Mr. Tally had concerns about having adequate time to respond if the Commission ordered a rate higher than what has been proposed. Brittany Koenig, Commission Staff, advised that he could file a motion with the Commission regarding that issue if needed.

There being no further discussion, the informal conference was then adjourned.
