He dreamed of creating a peaceful, safe, healthy space to raise his children, start a business, and to live the American Dream that he has fought so hard for. He and his wife, Janelle, have worked very hard to build their dream. With hard work, determination, and integrity, this dream has become a reality. However, this dream has become a nightmare, as of late.

In the great state, the great commonwealth, of Kentucky, it is illegal to knowingly devalue your neighbor's property. Yet, the Nicolai family is facing this exact issue. Their neighbor has reached an agreement with New Cingular Wireless/AT&T and Tillman Infrastructure to build a Cell Phone Tower within six hundred (600) feet of the Nicolai family farm and business. 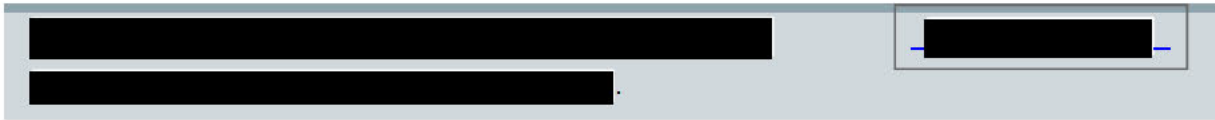

Comments: To Whom It May Concern Regarding Case # 2021-00398, The Rough River Lake area has a desperate need for additional cellular coverage. This has been a escalating concern over the last several years as folks needing to remain "connected" grows. This goes for both internet services over the cellular network as well as simple phone calls, since both are currently very limited based on location. Current service capabilities appear to be hindered or declining as the number of people visiting the area goes up. The service in our section of Rough River Lake works sporadically. Sometimes phone calls can be made but most times calls can only be made by driving to another geographical location. Internet services via a cellular connection has gotten worse over the years and today is non-existent in our area. As others have mentioned there are not many / any viable internet options for folks, outside of cellular connections. This would be improved by providing a new wireless tower, adding cellular connectivity to the area. Improvements to the wireless coverage area would also increase safety, with improved abilities to reach emergency services when and where needed. In addition to safety, new cellular coverage would also improve the overall

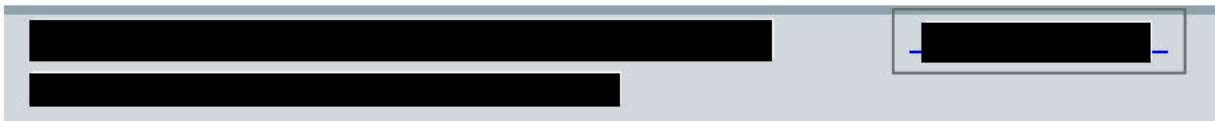

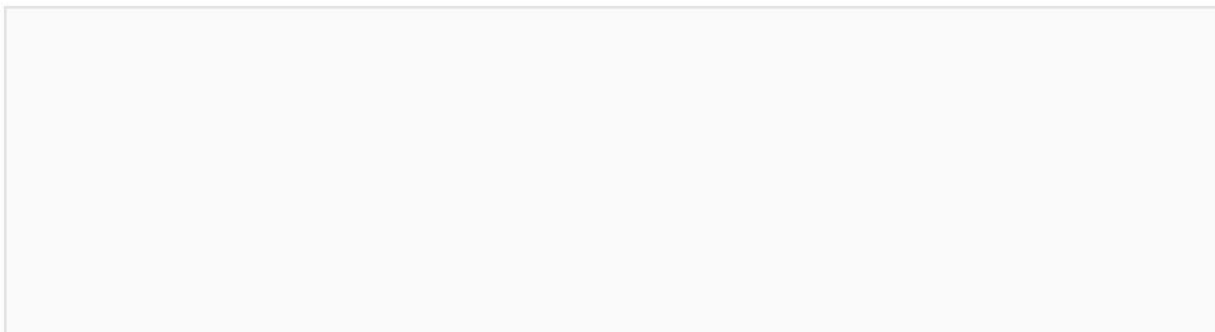
