**RE:** Informal Conference of March 9, 2022

On March 9, 2022, an informal conference (IC) was conducted in this matter. Attached is a copy of the attendance roster.

The purpose of the IC was to discuss a proposed amended to the Mitchell Ownership Agreement concerning Kentucky Power Company's (Kentucky Power) alternate proposal to divide the Mitchell units between Kentucky Power and Wheeling Power Company (Wheeling Power), the possibility of settlement, and other matters that may aid in the disposition of this proceeding. AEP/Kentucky Power representatives presented proposed alternative to Section 9.6 of the Mitchell Ownership Agreement with the options including a unit swap as a backstop if Kentucky Power and Wheeling Power are unable to mutually agree upon a sale of Kentucky Power's undivided interest or mutually agree with Wheeling to retire Mitchell. Commission Staff, Kentucky Industrial Utility Customers, Inc. (KIUC), and the Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention (Attorney General) discussed the proposal with AEP/Kentucky Power representatives.

There being no further discussion, the IC was then adjourned.
