The Commission Staff has reviewed the application in the above case. This filing is rejected for the reasons set forth below.

Filing deficiencies pursuant to:

- (1) <u>807 KAR 5:001 Section 4(3):</u> Name, address, telephone number, fax number, and e-mail address of submitting party or attorney; There is no email address or fax number for the submitting party.
- (2) 807 KAR 5:001 Section 4(4): A person shall not file a paper on behalf of another person, or otherwise represent another person, unless the person is an attorney licensed to practice law in Kentucky or an attorney who has complied with SCR 3.030(2). An attorney who is not licensed to practice law in Kentucky shall present evidence of his or her compliance with SCR 3.030(2) if appearing before the commission." In this case, Tara Wright filed and signed the application on behalf of the utility. Based on information provided by the district and belief, Tara Wright is not licensed to practice law in the Commonwealth of Kentucky. Although Daniel Briscoe with Dinsmore & Shohl, LLP signed the Notice of Intent (NOI) to file an application for authorization to enter into a financial obligation, he did not sign the application submitted by the district. In Order to proceed with this filing, the district must comply with 807 KAR 5:001 Section 4(4) and retain or clarify who will represent the utility's interests before the Commission. The attorney should file a Notice of Representation in this matter to ensure that all future filings and orders are served to the proper party.
- (3) <u>807 KAR 5:001 Section 8(4) (b):</u> Bookmarks added to distinguish sections of the paper; The Application is not bookmarked.
- (4) <u>807 KAR 5:001 Section 18(1) (g):</u> If the applicant is a water district, a copy of the applicant's written notification to the state local debt officer regarding the proposed issuance; There is a draft of the notification of the debt but no proof of actual notification to the state local debt officer.

You are requested to submit the information necessary to cure the deficiencies within 20 days of the date of this letter. If you need further assistance, please contact my staff at 502-564-3940.
