### A. PUBLIC SERVICE COMMISSION OF KENTUCKY RULES AND REGULATIONS

All gas service rendered by (B&S) will be in accordance with KRS 278.485 and all applicable rules and regulations established by the Public Service Commission of Kentucky (PSC of Kentucky).

### B. COMPANY (B&S) TERMS AND CONDITIONS

All gas service rendered by the 10 wells owned by B&S shall be in accordance with the terms and conditions set forth in this Application for Gas Service, in addition to PSC of Kentucky rules and regulations.

### C. REFUSAL OF SERVICE

B&S reserves the right to refuse or to defer full service to an applicant where the existing mains are inadequate to serve the applicants requirements without adversely affecting the service to the customers already connected and being served.

### D. APPLICATION FOR GAS SERVICE

B&S will require applicants to complete and sign an Application for Gas Service Pursuant to 807 KAR 5:026, Section 3, before service is supplied. The use of natural gas service constitutes an agreement under which the Customer receives natural gas service and agrees to pay the Company therefore in accordance with the applicable Tariff, and agrees to comply with the Rules and Regulations established by the PSC of Kentucky and the terms and conditions of the company (B&S). The company may refuse service to any customer who fails to comply with the Rules, Regulations, Terms, and Conditions of B&S. B&S will not furnish service to any applicant who owes the company any past due amount for service at any location, until all such indebtedness is paid in full.

#### SERVICE RULES, REGULATIONS AND CONDITIONS FOR SERVICE

#### E. MONTHLY BILLS

Bills for gas service will be rendered monthly. The meters shall be read at the end of each month (as nearly as may be practicable every thirty days), and bills will be due by the 20<sup>th</sup> of the following month. The timing of the meter cycle is selected by B&S.

B&S will exercise all reasonable means to assure accurate computation of all bills for natural gas service. If billing errors occur, the Company shall refund to Customer the amount of any overcharge and shall have the right to collect the amount of any undercharge due to the billing errors.

If an initial or final bill is for a period less than the monthly billing period described above, the billing will include the monthly minimum charge plus actual gas usage since the prior meter reading.

#### F. GENERAL PROVISIONS

B&S shall have the right to enter upon the premises of the Customer to read, repair, change or remove the meter or inspect regulators and shall also have the right to reclaim any of the property of B&S which may be on the premises.

Where the service facilities or other equipment have been tampered with, resulting in Improper measurement of the service supplied; the Customer shall be required to pay for such gas service as B&S may estimate from available information to have been used but not registered by B&S's meter, and in addition thereto, shall be required to bear all costs incurred by B&S for investigations and inspections.

No agent or employee of B&S has the authority to make any promise, agreement, or Representation inconsistent with this provision, and no such promise, agreement or representation shall bind B&S unless in writing and signed by an executive officer thereof.
