Protect Rooftop Solar and Hold LG&E and KU Accountable

The PSC was put in place to server the public. Hence the name. Otherwise it would have been called the Utility Service Commission. But it's not. The function of the Public Service Commission is to hold monopoly utilities accountable to the laws and regulations that govern them.

In the ruling on solar net metering in Kentucky, the PSC ruled that LGE/KU should use the same netting period as determined in the Kentucky Power case (monthly netting), that customer's in Kentucky have a monthly netting period, and that said credits should accrue over an entire billing cycle. This is not what is happening. Therefore, the commission must rule that the current LGE/KU tariff is void and implement monthly netting.

The scheme that LGE/KY is using as their tariff (instantaneous netting), is not what the name implies (netting). It is actually two channel billing and not only is unfair to the customer from a billing perspective given their investment in solar, it also makes it impossible for solar installers or customers to estimate their return on investment. The PSC needs to do everything within it's power to avoid confusion to customers and solar installers by making billing straightforward and also force the companies to make impacted customers whole by refunding what is due because of their scheme.

If the public can't trust the PSC to enforce their rulings and implement a course of action to ensure

the utilities are following up on the rulings, the PSC has no validity.

I implore you to act on this request not only in the interest of solar customers but in the interest that the PSC is seen as valid to the public, the utilities and the industry writ large. Thank you.
