Honorable Attorney General Cameron and the Kentucky Public Service Commission,

I, on behalf of the Persimmon Ridge Homeowners Association as its President, formally request that the KPSC and the Honorable Attorney General Cameron seek professional investigation and testimony regarding the case 2022-00432 with the KPSC.

We, as the largest subdivision serviced by Bluegrass Water in the state of Kentucky have only your offices to protect us as consumers from excessive rate increases in our utilities. With a significant rate increase already approved by the Commission in case 2020-00290 without expert testimony or investigation into the financial basis for the rate increases requested by Bluegrass Water, we feel that it is necessary in this case for the State to provide this due diligence to make sure its constituents are being protected from this for-profit business.

As noted in the dissenting opinion in rate case 2020-00290, it is Bluegrass Water's requirement to "(1) Provide reasonable, sufficient or competent financial information, (2) provide the information necessary to appropriately calculate a revenue requirement, and (3) generally meet its burden of proof as to its proposed rates." With a history of not meeting the burden of proof as stated in the dissenting opinion, and as noted by then Vice Chairman Chandler, "Compensation that is unreasonable, unsubstantiated and lacks an (sic) formal policy", we feel that it should be of utmost importance for the KPSC and the Attorney General to ensure that Bluegrass Water is meeting its burden of proof to state its case for why an additional rate increase is needed and why its profit is reasonable.

We also request that the basis of Bluegrass Water's justification for creating a single entity and rate for all 20 systems under its preview be investigated for its merits of creating economies of scale for all its customers. As Bluegrass Water continues to purchase additional facilities and lump them into these single pay rate cases, it also is unclear in their financials if they are accurately representing the profitability of their business when including these newly purchased facilities. This appears to create a case that Bluegrass Water is using purchases as justification for rate increases to fuel further purchases, rather than to accurately reflect the cost of servicing the utilities for its current customers. We formally request that this aspect of Bluegrass Water's financials and rate proposal also be investigated.

It is also unclear in Bluegrass Water's financials if they are justifying rate increases based on future and unapproved capital investment projects, which is not permissible as justification for rate increases in Kentucky. We formally request that this aspect of Bluegrass Water's financials and rate proposal also be investigated.

You may also find in Appendix A to this request a simple example justification for some of the above stated issues when investigating the financial documents in this and previous rate and purchase cases by Bluegrass Water.

Again, the KPSC and the Office of the Attorney General are the only protection for ensuring fair and reasonable rates for constituents such as ourselves. We therefore request with the utmost urgency for you to advocate on our behalf and intervene in this case to ensure that we are being fairly charged for the services being rendered, at a rate that is reasonable for our area and situation, and that gives only what is fair as a profit to Bluegrass Water.

Appendix A

355 of the 2,488 sewer connections for Bluegrass Water belong to Persimmon Ridge, representing 14.3% (the largest customer) of Bluegrass Water's customer base. In the 2023 operating budget, a total monthly revenue of \$202,966 was stated. At the current rate of \$85.97, Persimmon Ridge is generating \$366,232 per year. As stated in the Capital Pro Forma Adjustment filed by Bluegrass Water, the Persimmon Ridge facility is proposed to have \$253,000 of investment projects over the next three years. The requested increase would generate an additional \$57,084 per year from the Persimmon Ridge Development alone (for a total of \$423,316).

In 2019-00194 Pro forma income showed that PR Wastewater was functioning at a net income of (\$23,349) per year with a \$35 per month per home payment. This was with a \$138,563 yearly operating expense and a \$115,214 yearly revenue. Additionally, in the 2020 filing as part of 2019-00104 showed that the cost of operation and maintenance per plant site was \$4133 per month, or \$49,596 per year for Bluegrass water sites. Based on the Bluegrass cost of operation and maintenance number it would require a payment of \$11.64 to cover the cost of the system per household serviced by the PR system. In the most recent filing, all expenses for their business come in at \$253,987 per month. If we assume that economies of scale are being created, as voiced as justification by Bluegrass Water, and that the expense is evenly shared amongst the 20 facilities owned by Bluegrass Water, then the monthly cost for the PR sewer is \$12,699.35. This would equate to a cost per connection in PR of \$35.77 per month. Even if we used the pre-purchase operating cost when economies of scale were not to the systems cost benefit, we would still be at a total monthly payment of \$32.53. This alone would show that the assumption made by Bluegrass Water that economies of scale would lower costs for the facilities to be false as a pretense for lumping unrelated systems together under their company. This argument was, and is, being used to justify these increases falsely.

The purchase price of PR Wastewater in 2019 is believed to be \$237,807.47 per the case 2019-00104 post-closing accounting entries (The total cost of acquiring all 20 systems for Bluegrass water was \$1,861,351). As stated in the Capital Pro Forma Adjustment filed by Bluegrass Water, the Persimmon Ridge facility is proposed to have \$253,000 of investment projects over the next three years. In assuming the cost of purchase and the investment requested for the PR system, the total cost would amount to \$490,807.47. When accounting for the purchase price and investment needed on a 5-year payback method, it would add an additional \$23.04 payment per month, for a total breakeven analysis of \$34.68 (2020 filing operating cost), \$58.81 (2023 operating cost), or \$55.57 (Per-sale operating cost) given the budget you best believe represents the real cost to run the sewer facilities.

Given that this is a for-profit business, they are entitled to a profit (although it is in our opinion that fundamental human rights should include the right to safe water and wastewater management, and should not be held by private for-profit companies), so given the average net profit margin for utilities of 9.68% for the trailing 12 months ending in the first quarter of 2022, they should be entitled to a payment between \$38.04 and \$64.51 (depending on which cost method used) per service connection for Persimmon Ridge, with that cost decreasing once the capital investment and purchase price costs are recouped at the end of the 5-year payback analysis window. Please also keep in mind that Bluegrass has been reaping the profit of the previous rate increase for over a year with no stated investment, so one could argue the 5-year payback has already started.

As shown in the financial analysis above, this rate increase is not only not justified, but the current rate allowed by the PSC also exceeds the reasonable amount needed to generate a market average profit. Our recommendation is that the PSC re-evaluate the rate charges of PSC to the lower levels, implement a 5-year review that reduces rates further once initial capital and investment costs have been recouped, and ensure that future purchases of failing systems by Bluegrass Water are not used to justify increases to all customers. It is clear to us that this company, that has no employees in Kentucky, seeks to use acquisition and investment costs to justify extreme rates that generate above market average profits, while planning on adding additional profit in perpetuity to the bottom line once investments are recouped.
