<u>ORDER</u>

This matter arises upon the motion of the Wade Family Farm Management, LLC (Wade Farm), filed April 4, 2022, for full intervention. As a basis for its motion, Wade Farm states that the property will be directly affected by one of the proposed transmission lines routes proposed by Kentucky Utilities Company (KU). KU filed a response to numerous requests for intervention in this matter on April 12, 2022. The response did not address the request made by Wade Farm directly. In the response, KU objected to requests made by landowners whose land would not be directly affected by the proposed transmission lines.¹

LEGAL STANDARD

The only person who has a statutory right to intervene in a Commission case is the Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention (Attorney General), pursuant to KRS 367.150(8)(b). Intervention by all others is permissive and is within the sole discretion of the Commission.²

The statutory standard for permissive intervention, KRS 278.040(2), requires that "the person seeking intervention must have an interest in the 'rates' or 'service' of a utility, since those are the only two subjects under the jurisdiction of the PSC."³

The regulatory standard for permissive intervention, set forth in 807 KAR 5:001, Section 4, is twofold. Commission regulation 807 KAR 5:001, Section 4(11) requires a person to set forth in the motion to intervene either (1) a special interest in the proceeding that is not otherwise adequately represented in the case, or (2) that intervention is likely to present issues or develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings.

In cases involving an application for a Certificate of Public Convenience and Necessity (CPCN) to construct an electric transmission line, the Commission also considers KRS 278.020(9) which includes a person over whose property a proposed transmission line will cross as an "interested person" who may request intervention.

DISCUSSION AND FINDINGS

Based on a review of the pleadings at issue and being otherwise sufficiently advised, the Commission finds that Wade Farm demonstrated that it has a special interest in the proceeding over which the Commission has jurisdiction that is not otherwise adequately represented, for the reasons discussed below.

Wade Farm filed a timely request for intervention. One of the proposed transmission line routes will cross property owned by Wade Farm, and thus Wade Farm is an interested person as defined by KRS 278.020(9). It is reasonable to expect property

in the direct path of the proposed line to be impacted by the construction of the line if the CPCN is granted.

Although other landowners may be granted intervention, the size of this project means that not all landowners are situated equally. Based on the maps provided by KU,⁴ the proposed transmission lines will impact both farmland and suburban residential areas. Suburban homeowners and the owners of farm property have different interests because their land usage is different. Additionally, Wade Farm has obtained counsel, which the Commission expects may reduce confusion and assist in an orderly investigation of the proposed transmission line routes.

In footnote 2 of its response, KU implies that landowner(s) directly affected by the proposed transmission lines do have a special interest, and the company does not object to their participation.⁵

Based on the above, the Commission finds that Wade Farm is granted full rights of a party in this proceeding. The Commission directs Wade Farm to the Commission's July 22, 2021 Order in Case No. 2020-00085⁶ regarding filings with the Commission.

IT IS HEREBY ORDERED that:

1. The motion of Wade Farm to intervene is granted.

2. Wade Farm is entitled to the full rights of a party and shall be served with the Commission's Orders and with filed testimony, exhibits, pleadings, correspondence, and all other documents submitted by parties after the date of this Order.

3. Wade Farm shall comply with all provisions of the Commission's regulations, 807 KAR 5:001, Section 8, related to the service and electronic filing of documents.

4. Wade Farm shall adhere to the procedural schedule set forth in the Commission's April 6, 2022 Order and as amended by subsequent Orders.
