Telesto Energy Project LLC (Telesto), pursuant to 807 KAR 5:001, is to file with the Commission an electronic version of the following information. The information requested is due on November 17, 2022. The Siting Board directs Telesto to the Commission's July 22, 2021 Order in Case No. 2020-00085¹ regarding filings with the Commission. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked.

Each response shall include the question to which the response is made and shall include the name of the witness responsible for responding to the questions related to the information provided. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the

person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Telesto shall make timely amendment to any prior response if Telesto obtains information that indicates the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which Telesto fails or refuses to furnish all or part of the requested information, Telesto shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations. When filing a paper containing personal information, Telesto shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

1. Provide the Phase I Environmental Assessment.

2. Provide any communication or reports generated regarding areas of cultural or historic significance on the property.

 Provide the United States Army Corps of Engineers Wetland Delineation Report.

4. Provide any written communications or reports from the U.S. Department of Fish and Wildlife related to this project.

5. Provide documentation from the Kentucky Airport Zoning Commission stating a permit for the project is not necessary given the proximity to Addington Field.

6. Provide documentation on the renewable energy credit agreement.

7. Provide any easements or crossing agreements that have been executed for the collection system outside of the property boundary. Provide updates to this response as more easements or crossing agreements are finalized.

 Provide the results of soil tests conducted by the Environmental Protection Agency.

9. Refer to the Application, paragraph 21. Explain why Telesto, BP Solar, and BP Alternative Energy North America, Inc. were the named entities for documented environmental compliance.

10. List the company that will employ the individuals that are or will be responsible for ensuring compliance with the statements in the application and any conditions imposed by the Siting Board during construction and operations of the project.

11. Describe whether Telesto applied to PJM Interconnection LLC to be a Capacity Resource or an Energy Resource. If Telesto applied to be a Capacity Resource, state how many Capacity Interconnection Rights is Telesto seeking.
