1. The procedural schedule established on December 16, 2022, is amended.

2. The amended procedural schedule set forth in the Appendix to this Order shall be followed.

3. All provisions of the Commission's Order of December 16, 2022, in conflict with the provisions of this Order are vacated. All other provisions of the December 16, 2022 Order not in conflict shall remain in effect.
