On March 30, 2022, the Commission opened an investigation into Boone County Water District's (Boone District) proposed tariff revision eliminating the surcharge assessed to Subdistrict B for debt incurred by Boone District's predecessor in interest, the Boone County Fiscal Court. On June 14, 2022, Boone District filed a motion to incorporate the records of Cases No. 2002-00085,<sup>1</sup> No. 2005-00291,<sup>2</sup> and No. 2010-00065,<sup>3</sup> which contain facts relevant to the transfer of the water utility facilities, assignment of debt, the creation of Subdistrict B, and the assessment of the surcharge.

Under 807 KAR 5:001, Section 11(5), "Upon motion of a party to a proceeding, or upon the commission's own motion, the record of a case in the commission's files or any

document on file with the commission may be made a part of the record by 'reference only.'" Boone District argued that the records from these cases are necessary to provide a full and complete account of the parties' intentions and actions.

Having considered the motion, the Commission finds that Boone District's motion is granted. Allowing incorporation of these cases will provide for a more complete review of all information involved in the transfer. Requiring refiling would be unnecessarily redundant. As there are no intervenors in this matter, no parties will be prejudiced. The Commission generally grants motions to incorporate records from other cases.<sup>4</sup> Boone District has shown good cause to incorporate the designated parts of the record from Case Nos. 2002-00085, 2005-00291, and 2010-00065 pursuant to 807 KAR 5:001, Section 11(5).


IT IS THEREFORE ORDERED that:
