## ORDER

On March 8, 2022, Boone County Water District (Boone District) filed, through the Commission's electronic Tariff Filing System, revised tariffs removing Subdistrict A & B descriptions and respective \$25 surcharges from the tariff. On March 30, 2022, the Commission issued an order approving removal of the Subdistrict A surcharge and establishing this proceeding to investigate whether the \$25 Subdistrict B surcharge should be allowed to be removed from Boone District's tariff. The proposed removal of the Subdistrict B surcharge was suspended until August 31, 2022. Two rounds of discovery were completed, and the Commission also granted Boone District's motion to incorporate records from additional cases. On July 20, 2022, Boone District filed a notice

stating it was waiving its right to a public hearing and was submitting this matter for a decision based upon the existing evidence of record. The Commission has received information sufficient to issue a ruling in this case.

# <u>BACKGROUND</u>

In 2002, the Commission approved Boone County Fiscal Court's request to create a water service area referred to as Subdistrict A and the assessment of a \$25 surcharge to this subdistrict to be applied to repayment of the general obligation bonds issued to finance construction of infrastructure extending service to that area.<sup>4</sup> At the time the Commission approved Boone County Fiscal Court's application, Boone County Fiscal Court contracted with Boone District to operate the water facilities.<sup>5</sup>

In 2006, the Commission approved Boone County Fiscal Court's request to create a water service area referred to as Subdistrict B and another accompanying \$25 surcharge to be applied to repayment of a Kentucky Infrastructure Authority (KIA) Ioan used to finance construction of infrastructure extending service to the area.<sup>6</sup> At the time the Commission approved Boone County Fiscal Court's application to create Subdistrict A,<sup>7</sup> and later to construct Subdistrict B, it was not economically feasible for Boone District to extended service into those areas.<sup>8</sup>

In 2010, Boone County Fiscal Court and Boone District filed jointly for approval of transfer of Boone Fiscal Court's Subdistricts A and B water facilities to Boone District in the form of a lease and purchase option for Subdistrict A facilities and the outright sale of Subdistrict B facilities.<sup>9</sup> The agreement included Boone District assuming both subdistricts' debts.<sup>10</sup> The Commission approved the transfer pursuant to KRS 278.020(5)-(6),<sup>11</sup> and also approved the assumption of debts.<sup>12</sup>

The Commission's final Order in Case No. 2010-00065 ordered Boone District to maintain separate records of the collection of all surcharge revenues from Subdistrict A and Subdistrict B to ensure an accurate accounting of surcharge collections. Additionally, the final Order in Case No. 2010-00064 included an ordering paragraph pertaining to Subdistrict A, and another ordering paragraph pertaining to Subdistrict B, stating that Boone District was authorized to assess a monthly surcharge of \$25 to customers of each subdistrict until complete satisfaction of Boone District's obligations under the Assumption and Supplemental Assistance Agreement, and that upon satisfaction of these obligations, Boone District would cease assessing the surcharge.

Boone District has paid the Subdistrict A debt in full.<sup>15</sup> The Subdistrict B debt has yet to be paid in full, with an outstanding balance of approximately \$1.4 million and a

scheduled repayment date in 2037.<sup>16</sup> Boone District filed a tariff revision removing both subdistrict surcharges. Boone District indicated that it would use its general funds to pay the remaining debt service for the Subdistrict B KIA loan, stating that it had adequate revenues to pay the remaining debt service without any effect on existing rates.<sup>17</sup> In making its tariff filing Boone District is effectively asking the Commission to modify the terms of its final Order in Case No. 2010-00065 and permit Boone District to cease assessing a monthly \$25 surcharge to customers of Subdistrict B before Boone District has satisfied the obligations it assumed on behalf of Subdistrict B under the Assumption and Supplemental Assistance Agreement.

# LEGAL STANDARD

The Commission may revoke or modify any of its previous orders. Specifically, KRS 278.390 in relevant part states, "Every order entered by the commission shall continue in force until the expiration of the time, if any, named by the commission in the order, or until revoked or modified by the commission, unless the order is suspended, or vacated in whole or in part, by order or decree of a court of competent jurisdiction." Pursuant to KRS 278.030(1), every utility may demand, collect and receive fair, just and reasonable rates for services rendered.

## <u>DISCUSSION</u>

In support of its tariff filing Boone District stated that the removal of the Subdistrict B surcharge is fair, just and reasonable because the surcharge never covered the full

cost of the debt incurred to finance Subdistrict B,<sup>18</sup> removal of the surcharge would not cause a rate increase because debt payments will be made from its general funds,<sup>19</sup> and other Boone District customers have benefited from the systems extended to Subdistrict B.<sup>20</sup> Boone District stated that the reason for the removal of the surcharge was that removal of both subdistrict surcharges simultaneously would facilitate Boone District's ability to obtain public funding from Boone County Fiscal Court for system expansion to additional areas.<sup>21</sup> Boone District cited instances in which the Commission approved extensions of service and permitted subsidization of these extensions by all ratepayers.<sup>22</sup>

# **FINDINGS**

Having considered the evidence of record, and being otherwise sufficiently advised, the Commission finds that the May 11, 2010 final Order in Case No. 2010-00065 shall be amended to authorize Boone District to cease assessment of the monthly \$25 surcharge to Subdistrict B customers as of September 1, 2022.

The Commission supports merger, consolidation, or transfer of water systems when those transactions are intended to improve the rates, service, financial stability, and management of those systems.<sup>23</sup> The Commission does not seek to discourage improving the governance of these systems or extending service to new areas by refusing to modify the conditions imposed by its final Order in Case No. 2010-00065. Although the Commission often approves rates intending to assign costs only to customers receiving the benefits of these costs,<sup>24</sup> the Commission also has also supported unified rate structures allowing the costs of extending service to new customers to be paid uniformly across the customer base.<sup>25</sup> In the present case, due to the fact the surcharge

revenue has fallen short of the debt service each year since its implementation,<sup>26</sup> the Subdistrict B debt is already being paid in part by the general funds of Boone District.<sup>27</sup> Rates will not be increased as a result of this change. Non-Subdistrict B average customers' share of the cost will increase from approximately \$0.05 to \$0.23 per month.<sup>28</sup> Subdistrict B customers will receive a \$25 per 1,000-gallon rate decrease. The Commission finds that this change supports the improvement and expansion of water service by merger and results in rates that are fair, just and reasonable under KRS 278.030(1).

#### IT IS THEREFORE ORDERED that:

- The condition imposed by ordering paragraph 9 of the Commission's May
  2010 final Order in Case No. 2010-00065 is void on September 1, 2022.
- 2. Boone District's proposal to remove the \$25 Subdistrict B surcharge from its tariff is approved for service rendered on and after September 1, 2022.
- 3. Within 20 days of the date of service of this Order, Boone District shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff
