ORDER

On May 7, 2024, the Commission issued an Order that, in addition to making certain clarifications, granted rehearing in this matter. The Order inadvertently contained an ordering paragraph closing the case. It also did not explicitly include the language referring to member cooperatives in another ordering paragraph.

Finding that the May 7, 2024 Order should be amended, the Commission HEREBY ORDERS, *nunc pro tunc*, that:

1. Ordering paragraph 6 is stricken.
2. Ordering paragraph 3 is stricken and is replaced with the following


language:
