## <u>O R D E R</u>

On April 14, 2023, Water Service Corporation of Kentucky (Water Service Kentucky) filed a motion to correct the April 12, 2023 Order that, among other things, approved a rate increase. Water Service Kentucky requested an expedited review because bills issued later in April will reflect rates effective as of the April 12, 2023 Order. The Commission will treat the motion as a motion for rehearing pursuant to KRS 278.400.

### LEGAL STANDARD

KRS 278.400, which establishes the standard of review for motions for rehearing, limits any new evidence on rehearing to evidence not readily discoverable at the time of the original hearings, to correct any material errors or omissions, or to correct findings that are unreasonable or unlawful. A Commission Order is deemed unreasonable only when "the evidence presented leaves no room for difference of opinion among reasonable minds."<sup>1</sup> An Order can only be unlawful if it violates a state or federal statute or constitutional provision.<sup>2</sup>

By limiting rehearing to correct material errors or omissions, and findings that are unreasonable or unlawful, or to weigh new evidence not readily discoverable at the time of the original hearings, KRS 278.400 is intended to provide closure to Commission proceedings. Rehearing does not present parties with the opportunity to relitigate a matter fully addressed in the original Order.

### MOTION TO CORRECT ORDER

Water Service Kentucky alleged that the April 12, 2023 Order contains a material error because the rates identified in the Appendix to that Order do not accurately reflect the authorized revenue requirement increase contained in the body of the Order. Water Service Kentucky explained that, in the body of the Order, the Commission authorized a \$616,566, or 18.90 percent, revenue increase that was allocated evenly across the customer classifications. Water Service Kentucky asserted that, when the utility's billing determinants filed in this case are applied, the rates identified in the Appendix to the April 12, 2023 Order produce a revenue increase of \$520,598, which is lower than the \$616,566 revenue increase approved by the Commission. Water Service Kentucky provided a table of the rates that would result from an 18.90 percent increase, as referenced in the April 12, 2023 Order.

#### **DISCUSSION AND FINDINGS**

Based upon the motion, April 12, 2023 Order, and being otherwise sufficiently advised, the Commission finds that Water Service Kentucky's motion for rehearing should be granted. This is because the Commission concludes that the Appendix to the April 12, 2023 Order contained rates that did not reflect the approved 18.90 percent revenue increase, and thus the April 12, 2023 Appendix contained a material error. The rates contained in the April 12, 2013 Appendix were based upon a revenue increase of 15.96 percent instead of the correct 18.90 percent revenue increase. These rates would only result in a revenue increase of \$520,598 instead of the calculated increase of \$616,566. The corrected rates in the Appendix to this Order will increase the average bill of a residential customer using 3,438 gallons per month from \$33.09 to \$39.35, an increase of \$6.26, or approximately 18.92 percent.

An Appendix with the correct rates is attached to this Order. These rates are effective as of the date of entry of the April 12, 2023 Order.

IT IS THEREFORE ORDERED that:

1. Water Service Kentucky's motion for rehearing is granted.

2. The Appendix to the April 12, 2023 Order is stricken and replaced with the Appendix attached to this Order.

3. The rates contained in the Appendix to this Order are approved for service rendered on and after April 12, 2023.

4. Within 20 days of service of this Order, Water Service Kentucky shall file with the Commission, using the Commission's Electronic Tariff Filing System, new tariff

sheets setting forth the rates and charges and the revisions approved herein and reflecting their respective effective dates and that they were authorized by this Order.

5. This case is closed and removed from the Commission's docket.
