COMMISSION STAFF'S POST-HEARING REQUEST FOR INFORMATION
TO EAST KENTUCKY MIDSTREAM, LLC

East Kentucky Midstream, LLC (EKM), pursuant to 807 KAR 5:001, shall file with the Commission an electronic version of the following information. The information requested is due no later than June 10, 2025. The Commission directs EKM to the Commission's July 22, 2021 Order in Case No. 2020-00085¹ regarding filings with the Commission. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked.

Each response shall include the question to which the response is made and shall include the name of the witness responsible for responding to the questions related to the information provided. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the

response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

EKM shall make timely amendment to any prior response if EKM obtains information that indicates the response was incorrect or incomplete when made or, though correct or complete when made, is now incorrect or incomplete in any material respect.

For any request to which EKM fails or refuses to furnish all or part of the requested information, EKM shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied and scanned material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations. When filing a paper containing personal information, EKM shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

1. Provide a copy of any written contracts, not previously provided, for all natural gas service to the city of West Liberty, West Liberty State Penitentiary, and any schools or an entity operating such facilities.
2. Provide a sample residential contract for natural gas service.
3. Provide the lost and unaccounted for gas (LUG) by month beginning in January 2023 through April 2025.

4. Provide the amount of local production being sold into the interstate market at Means by month beginning in January 2023 through April 2025.

5. Provide the amount of natural gas purchased from TC Energy for the period of January 2022 through April 2025.

6. Provide a list of critical days as designated by TC Energy for the period beginning in January 2024 through April 2025.
