ORDER

On December 15, 2022, Cumberland County Water District (Cumberland District) filed a motion seeking an extension of time of 20 days to file responses to the Commission Staff's First Request for Information. In support of its motion, Cumberland District stated that it needed more time to provide complete answers to the data request; the district is in the process of changing managers; and the county attorney is changing.

The Commission finds that good cause has been shown to grant Cumberland District's request. The Commission notes that the continuance will not result in prejudice to any party, and there is no statutory deadline to process this case. The Commission also desires complete, thorough answers to the data request.

IT IS THEREFORE ORDERED that:

1. Cumberland District's motion is granted.
2. Responses to Commission Staff's First Request for Information shall be filed on or before January 5, 2023.
