ORDER

The Commission, on its own motion, HEREBY ORDERS that:

- 1. A hearing in this matter shall be held on Tuesday, April 4, 2023, at 9 a.m. Eastern Daylight Time, and continuing until called from the bench by the presiding officer, in the Richard Raff Hearing Room at the offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky.
- 2. Pursuant to 807 KAR 5:001E, Section 2, if the hearing is not concluded on the designated day, the hearing may be continued upon verbal announcement by the presiding officer. A verbal announcement made by the presiding officer shall be proper notice of the continued hearing.
- 3. Witnesses who sponsor schedules, testimony, or responses to data requests shall participate in person at the April 4, 2023 hearing.
- 4. If Matthew Dyer separates from the utility prior to the hearing date, Mr. Dyer shall testify at the April 4, 2023 hearing as a sponsor of testimony and responses to data requests. Counsel for Cumberland County Water District (Cumberland District) shall

notify the Commission immediately if Matthew Dyer separates from the utility for any reason.

- 5. Counsel shall file a witness list in the record by March 28, 2023.
- 6. Records and filings for Case No. 2022-00291¹ are hereby incorporated into the record of this case and may be referenced by any party during the hearing and any further proceedings or orders.
- 7. Cumberland District shall give notice of the hearing in compliance with 807 KAR 5:001E, Section 9(2)(b). In addition, the notice of hearing shall include the following statements: "This hearing will be streamed live and may be viewed on the PSC website, psc.ky.gov"; and "Public comments may be made at the beginning of the hearing. Those wishing to make oral public comments may do so by following the instructions listed on the PSC website, psc.ky.gov." At the time the notice is mailed or publication is requested, Cumberland District shall forward a duplicate of the notice and request to the Commission.
- 8. Pursuant to KRS 278.360 and 807 KAR 5:001E, Section 9(9), a digital video transcript shall be made of the hearing.
