## <u>O R D E R</u>

On March 27, 2023, Cumberland County Water District (Cumberland District) filed a motion requesting that two witnesses be excused from the hearing schedule for April 4, 2023. As grounds for the request, Cumberland District stated that Eric Carver would be out of town<sup>1</sup> and Sandra Hieneman is the sole caretaker for an ill family member. Each party had prepared and attached a sworn affidavit asserting those facts.<sup>2</sup>

The Commission finds that Cumberland District has shown good cause to excuse Eric Carver and Sandra Hieneman. Neither party sponsored any testimony. The Commission would note that, should no party in attendance at the hearing be able to answer a question that Mr. Carver or Ms. Hieneman would best be able to best answer, the respective party will be expected to respond under oath by writing at a later date.

IT IS HEREBY ORDERED that the motion of Cumberland District is granted.
