ORDER

On March 9, 2023, Duke Energy Kentucky, Inc. (Duke Kentucky) and the Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention (Attorney General), jointly filed a motion requesting that the Commission schedule an informal conference (IC) for the purpose of discussing the status of the case and possible settlement and resolution of any issues. Based upon the motion, the Commission finds that the parties have established good cause to schedule an IC, and therefore the motion should be granted. The parties to the case are cautioned that the Commission speaks solely through its Orders and that any resolution of issues between parties will be considered but is not binding on the Commission. An IC is scheduled on March 15, 2023, at 3:00 p.m. Eastern Daylight Time. IT IS THEREFORE ORDERED that:

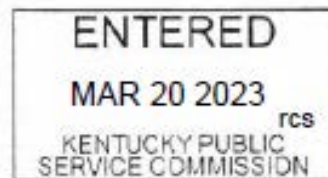
1. The joint motion to schedule an IC is granted.
