6. This case shall stand submitted for a decision by the Commission effective 12:01 a.m. Eastern Daylight Time, May 13, 2023.

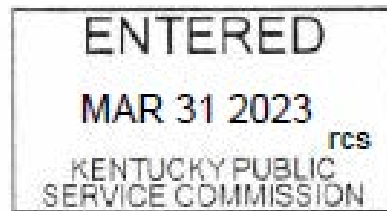
