The Commission, pursuant to 807 KAR 5:056, Section 3(3), hereby initiates the six-month review to examine the application of the Fuel Adjustment Clause of Jackson Purchase Energy Corporation, Kenergy Corp., and Meade County Rural Electric Cooperative Corporation (collectively, Cooperatives or individually Cooperative) from November 1, 2021, through April 30, 2022.

IT IS THEREFORE ORDERED that:

1. Each Cooperative shall individually file with the Commission, no later than October 21, 2022, an affidavit attesting to its compliance or noncompliance with the requirements of 807 KAR 5:056. The Commission directs the Cooperatives to the Commission's July 22, 2021 Order in Case No. 2020-00085¹ regarding filings with the Commission. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked.

2. All documents that the Cooperatives filed with the Commission pursuant to 807 KAR 5:056, Section 2(1)-2(4), during the period under review are incorporated by reference into the record of this proceeding.

3. Unless otherwise ordered by the Commission, the electronic filing procedures set forth in 807 KAR 5:001, Section 8, shall be followed when filing papers in this proceeding. As set forth in 807 KAR 5:001, Section 4(11)(a), a person requesting permissive intervention in a Commission proceeding is required to demonstrate either (1) a special interest in the proceedings which is not adequately represented in the case, or (2) that the person requesting permissive intervention is likely to present issues or develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings. Further, KRS 278.040(2) requires that a person seeking intervention must have an interest in the rates or service of a utility, as those are the only matters that are subject to the Commission's jurisdiction.

Based on the foregoing, the Commission finds that any person requesting to intervene in a Commission proceeding must state with specificity the person's special interest that is not adequately represented or the issues and facts the person will present that will assist the Commission in fully considering the matter. A mere recitation of the quantity of electricity consumed by the movant or a general statement regarding a potential impact of a possible modification of rates will not be deemed sufficient to establish a special interest.

4. Any request for intervention must be filed by September 30, 2022.

5. A person who submits a motion to intervene after September 30, 2022, and, upon a showing of good cause, is granted full intervention shall accept and abide by the existing procedural schedule.

6. Any request for a hearing, or that the case should be submitted on the record, shall be filed no later than November 30, 2022.
