ORDER


On April 10, 2023, Kentucky Solar Energy Society, Mountain Association, and the Kentucky Resources Council, Inc. (collectively, Joint Intervenors) moved the Commission to admit *pro hac vice* Hema Lochan, an attorney whose office is in New York, and Thomas Cmar, an attorney whose office is in Ohio, in two separate motions, to practice law before the Commission on behalf of Joint Intervenors in association with Tom Fitzgerald and Ashly Wilmes, attorneys licensed to practice law in the Commonwealth of Kentucky, in this case. In support of the request, Hema Lochan and Thomas Cmar have shown that they are members in good standing of another state bar and have paid the required fee to be certified to practice before the Commission in this case by the Kentucky Bar Association under Supreme Court Rule 3.030(2). In addition, Hema Lochan and Thomas Cmar have agreed to be subject to the jurisdiction and rules of the Commission and the Kentucky Bar Association.

IT IS THEREFORE ORDERED that Hema Lochan and Thomas Cmar are admitted *pro hac vice* for the purpose of representing collectively Joint Intervenors in association with Tom Fitzgerald and Ashly Wilmes in the above-styled proceeding, provided that Tom FitzGerald, Ashly Wilmes, or another member of the Kentucky Bar Association acts as

co-counsel and is present at all proceedings before this Commission. Furthermore, Joint Intervenors shall file proof that Hema Lochan, and Thomas Cmar have been certified to practice before the Commission in this case by the Kentucky Bar Association under Supreme Court Rule 3.030(2) within ten days of service of this Order.
