## ORDER

IT IS THEREFORE ORDERED that Hema Lochan and Thomas Cmar are admitted pro hac vice for the purpose of representing collectively Joint Intervenors in association with Tom Fitzgerald and Ashly Wilmes in the above-styled proceeding, provided that Tom FitzGerald, Ashly Wilmes, or another member of the Kentucky Bar Association acts as

co-counsel and is present at all proceedings before this Commission. Furthermore, Joint Intervenors shall file proof that Hema Lochan, and Thomas Cmar have been certified to practice before the Commission in this case by the Kentucky Bar Association under Supreme Court Rule 3.030(2) within ten days of service of this Order.
