ORDER

The parties should ensure, during the hearing, they have 15 copies of

each potential exhibit to tender to other parties, Commission Staff, and Commissioners as well as the ability to provide an electronic copy to the Commission and its court reporter upon request, either by email or another format. The order for witness testimony will be the Applicant, the Attorney General, Sierra Club, Kentucky Broadband and Cable Association (KBCA), Wal-Mart Inc. (Walmart), and The Kroger Co. (Kroger), unless otherwise dictated by Commission Order. The order for cross-examination shall be the Attorney General, Sierra Club, KBCA, Walmart, Kroger, and Commission Staff.

IT IS THEREFORE ORDERED that:

- 1. All parties shall submit a list of witnesses expected to testify at the hearing on or before May 4, 2023.
- 2. All parties shall ensure a sufficient number of copies of the exhibits at the hearing.
- 3. The order for witnesses shall be the Applicant, the Attorney General, Sierra Club, KBCA, Walmart, and Kroger.
- 4. The order for cross-examination shall be the Attorney General, Sierra Club, KBCA, Walmart, Kroger, and Commission Staff.
