ORDER

On April 19, 2023, Walmart, Inc. (Walmart) filed a motion requesting that its expert, Steve Chriss, be given a date certain of May 11, 2023, to testify at the May 9, 2023, through May 12, 2023 hearing in this matter.¹ As grounds for the motion, Walmart stated that Mr. Chriss was scheduled to appear at a conference scheduled for May 9, 2023, through May 11, 2023, in Seattle, Washington. Mr. Chriss planned to leave early and appear in person at the hearing in this matter on May 11, 2023.

The Commission finds that Walmart has demonstrated good cause for granting the motion. Mr. Chriss will appear in person with a date certain to testify to account for work commitments. Permitting Mr. Chriss to appear on May 11, 2023, to testify does not prejudice the Commission or any other party to the case.

1. Walmart's motion is granted.
