ORDER

On May 22, 2023, Kentucky Power Company (Kentucky Power) filed a motion requesting to reschedule the hearing scheduled for June 21, 2023, because one of its witnesses will be out of the country and unavailable to testify for the entire week of June 19-23, 2023. Kentucky Power requested the hearing be continued to July 11-14, 2023, or July 17-21, 2023.

On May 23, 2023, the Attorney General filed a response stating no opposition to the change in the hearing date, but that counsel would not be available July 21, 2023, or July 24-28, 2023.

On May 24, 2023, Mountain Association, Kentuckians for the Commonwealth, Appalachian Citizens' Law Center, Sierra Club, and Kentucky Resources Council, Inc. (collectively, Joint Intervenors) filed a joint response stating no opposition to the change in the hearing date, but requested that, if the hearing is rescheduled, that the hearing be scheduled between July 18-20, 2023, because those are the only proposed dates that counsel and witnesses for Joint Intervenors will be available.

Having considered the motion, the Commission finds that Kentucky Power established good cause to reschedule the hearing given the unavailability of a Kentucky

Power witness. For this reason, the Commission grants the motion and reschedules the hearing for July 20, 2023.


IT IS HEREBY ORDERED that:

1. The motion to reschedule the hearing is granted.
2. A hearing in this matter shall be held on July 20, 2023, at 9 a.m. Eastern Daylight Time, in the Richard Raff Hearing Room at the offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky.
3. Pursuant to 807 KAR 5:001E, Section 2, if the hearing is not concluded on the designated day, the hearing shall be continued upon verbal announcement by the presiding officer. A verbal announcement made by the presiding officer shall be proper notice of the continued hearing.
4. Witnesses who sponsor schedules, testimony, or responses to requests for information shall participate in person at any hearing scheduled in this matter.
5. Kentucky Power shall give notice of the hearing in compliance with 807 KAR 5:001E, Section 9(2)(b). In addition, the notice of hearing shall include the following statements: "This hearing will be streamed live and may be viewed on the PSC website, [psc.ky.gov](http://psc.ky.gov)" and "Public comments may be made at the beginning of the hearing. Those wishing to make oral public comments may do so by following the instructions listed on the PSC website, [psc.ky.gov](http://psc.ky.gov)." At the time the notice is mailed or publication is requested, Kentucky Power shall forward a duplicate of the notice and request to the Commission.
6. Pursuant to KRS 278.360 and 807 KAR 5:001E, Section 9(9), a digital video transcript shall be made of the hearing.

7. The parties shall file a witness list no later than five days prior to the July 20, 2023 hearing.

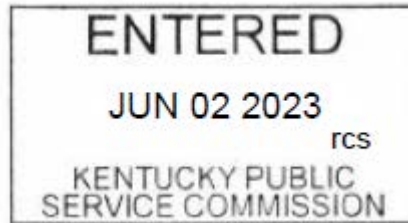
