## ORDER

On July 24, 2023, Kentuckians for the Commonwealth, Kentucky Solar Energy Society, Mountain Association, and Metropolitan Housing Coalition (collectively, Joint Intervenors) filed a motion requesting leave to file corrected witness testimony for Andy McDonald, which was tendered with the motion. In support of the motion, the Joint Intervenors stated that a portion of Mr. McDonald's testimony was inadvertently omitted when originally filed on July 14, 2023. The Joint Intervenors further stated that the amended testimony was shared with counsel for Louisville Gas & Electric Company and Kentucky Utilities Company (jointly, LG&E/KU), and that Joint Intervenors stated that LG&E/KU did not object to filing the corrected testimony.

Based upon the motion and being otherwise sufficiently advised, the Commission finds the motion should be granted. This is because Joint Intervenors established good cause given that the omission that was corrected is relatively short in length and thus should not result in prejudice to any party. Although Commission Staff and other parties

may not be able to include questions related to the corrected testimony in the requests for information that have a procedural due date of July 28, 2023, Commission Staff and other parties will have the opportunity to cross-examine Mr. McDonald on the corrections to his testimony at the hearing scheduled to begin on August 22, 2023, at 9:00 a.m. Eastern Daylight Time.

## IT IS THEREFORE ORDERED that:

- The Joint Intervenors motion to file corrected witness testimony for Andy
   McDonald is granted.
- 2. The testimony of Mr. McDonald filed on July 14, 2023 is stricken and replaced with the corrected testimony of Mr. McDonald filed on July 24, 2023.
