On August 25, 2023, Metropolitan Housing Coalition (MHC), Kentuckians for the Commonwealth (KFTC), Kentucky Solar Energy Society (KYSES), and Mountain Association (MA) (collectively, Joint Intervenors) filed a motion requesting that Cassandra McCrae be permitted to conduct direct examination of Joint Intervenors' witnesses and cross examination of other parties' witnesses remotely. As a basis for the request, Joint Intervenors stated that, due to a health issue, Ms. McCrae could not participate in person at the hearing in this matter during the week of August 28, 2023.

Based upon the motion, the Commission finds that Joint Intervenors established good cause because Ms. McCrae is not available to participate in person due to a health issue and the motion should be granted. Commission Staff will provide Ms. McCrae with instructions to ensure that Ms. McCrae has sufficient capability to participate remotely in this hearing the week of August 28, 2023.

IT IS THEREFORE ORDERED that Joint Intervenors' motion is granted.
