## ORDER

On November 30, 2022, Kentucky Frontier Gas, LLC (Kentucky Frontier) filed a revision to its tariff to establish a gas cost reconciliation charge of \$0.1000 per Ccf or \$1.0000 per Mcf with a proposed effective date of December 30, 2022. Kentucky Frontier filed proposed 28th revised Tariff Sheet No. 4, which would cancel the 27th revised Tariff Sheet No. 4. It included the gas cost reconciliation adjustment and was filed in the tariff filing system and included supporting documents. Kentucky Frontier claimed that the gas cost reconciliation charge addressed the under-recovered balance through the current gas cost recovery (GCR) mechanism.

On December 28, 2022, the Commission entered an Order opening this case and suspended Kentucky Frontier's proposed tariff for five months from December 30, 2022, up to and including May 29, 2023, to determine the reasonableness of the proposed tariff. In the December 28, 2022 Order, the Commission noted that it had a pending proceeding in Case No. 2022-00327<sup>1</sup> regarding Kentucky Frontier's quarterly purchased gas adjustment related to the subject matter of this proceeding, finding that Case No. 2022-

00327 should be combined with this case, with future filings submitted in both cases for the purpose of administrative efficiency and that both cases remain open.

On February 16, 2023, Kentucky Frontier filed a motion to withdraw its tariff filing and supporting documents of November 30, 2022, given the duplication across several cases. On February 24, 2023, in Case No. 2023-00067, Kentucky Frontier tendered an application to revise its quarterly gas cast recovery schedules.<sup>2</sup>

Having reviewed the record and being otherwise sufficiently advised, the Commission finds that Kentucky Frontier's motion to withdraw its tariff filing with its proposed revision to its GCR mechanism should be granted. The Commission further finds that this case should be dismissed without prejudice because it was initiated by the Commission to investigate the reasonableness of Kentucky Frontier's revised tariff that has now been withdrawn. The dismissal of this matter will not have any effect on the Commission's review of Kentucky Frontier's quarterly purchased gas adjustment in Case No. 2022-00327.

## IT IS THEREFORE ORDERED that:

- 1. Kentucky Frontier's motion to withdraw its revised tariff filed on November 30, 2022, proposing to establish a gas cost reconciliation charge of \$0.1000 per Ccf is granted.
  - 2. This case is dismissed without prejudice.
  - 3. This case is closed and removed from the Commission's docket.
