ORDER

This matter is before the Commission upon a motion filed on July 28, 2023, by Bluegrass Water Utility Operating Company, LLC (Bluegrass Water), pursuant to 807 KAR 5:001, Section 22, requesting a deviation from the requirement in 807 KAR 5:001, Section 8(3) that parties upload an electronic version of all papers filed in this proceeding to the Commission's website using the Commission's E-Filing System.

LEGAL STANDARD

Section 8(3) of 807 KAR 5:001 provides in an electronic case that "[a]II papers shall be filed with the commission by uploading an electronic version using the commission's E-Filing System at http://psc.ky.gov." Pursuant to 807 KAR 5:001, Section 22, the Commission may permit deviations from that requirement in special cases, for good cause shown.

<u>DISCUSSION</u>

Bluegrass Water seeks a deviation for video files being produced in response to Commission Staff's Fourth Request for Information, Item 10(b). In support of its motion, Bluegrass Water stated that these video files exceed the individual file sizes for uploading

into the Commission's E-Filing System and cannot be further reduced.¹ Counsel for Bluegrass Water contacted Commission Staff to make accommodations to serve the Commission with the video files via electronic share file, thumb drive, or CD so that the video files could be made part of the record and accessible to the public.²

Having reviewed the motion and being otherwise sufficiently advised, the Commission finds that Bluegrass Water has established good cause to permit it to deviate from filing the video files in question electronically pursuant to 807 KAR 5:001, Section 8(3). The Commission notes that the video files in question exceed the limitation for uploads to the Commission's E-Filing System, and are unable to be reduced. Therefore, the Commission finds that Bluegrass Water's request for a deviation from filing the information electronically pursuant to 807 KAR 5:001, Section 8(3) should be granted.

IT IS THEREFORE ORDERED that Bluegrass Water's motion for a deviation is granted.
