NOTICE OF ELECTION OF USE OF ELECTRONIC FILING PROCEDURES

(Complete All Shaded Areas and Check Applicable Boxes)

In accordance with 807 KAR 5:001, Section 8, Duke Energy Kentucky, Inc. gives notice of its intent to file an application for Gas Cost Adjustment with the Public Service Commission no later than January 28, 2022 and to use the electronic filing procedures set forth in that regulation.

Duke Energy Kentucky, Inc. further states that:

- 1. It requests that the Public Service Commission assign a case number to the intended application and advise it of that number as soon as possible;
