Pursuant to an order issued on February 9, 2023, an informal conference (IC) was conducted on February 13, 2023. Attached is a copy of the attendance roster.

Duke Energy Kentucky, Inc. (Duke) filed a motion for an IC on February 6, 2023. The stated purpose of the IC was to discuss settlement between Duke and the Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention (Attorney General).

Duke also filed a motion to amend the procedural schedule on February 9, 2023, requesting a continuance of the hearing originally set for February 22, 2023. During the IC, the parties indicated a desire to file agreed upon settlement stipulations followed by a hearing to resolve any remaining issues.

There being no further discussion, the IC was then adjourned.
