RE: Informal Conference of December 12, 2022

Pursuant to an Order issued on December 5, 2022, an informal conference (IC) was conducted on December 12, 2022. Attached is a copy of the attendance roster.

The purpose of the IC was to discuss data request responses. Rowan Water uses Ampstun software for accounting and billing purposes. Ms. Honaker was unsure about what was requested as part of a General Ledger and what was requested as part of a Trial Balance. Travis Leach explained what each one looked like and that they were not interchangeable in the information that was provided. Quikbooks usually has a shortcut to the report but no Team members were familiar with the software Rowan Water used. Travis Leach provided an example of a recent case for examples of how certain information should be formatted and provided to the Commission.

Even if though are no work papers, the manager can summarize how certain figures were arrived at. With the purchase power agreements, an Excel sheet would be the best format, with a tab for each utility.

Jason Green requested that the utility use the cost justifications forms found on the PSC website. He also noted that the names on the justification sheets provided didn't necessarily match the tariff on file and it would be helpful if the information matched the tariff names on file. He also explained that the nonrecurring charges can be listed as a total of # of occurrences and the amount collected. No customer information was required to provide the needed information.

This led to a discussion of the motion for confidential treatment filed by Rowan Water. Because the motion included an extensive amount of customer information, Ms. Honaker is going to file an updated filing.

There being no further discussion, the IC was then adjourned.
