Dear Public Service Commission,

I support the comment submitted by Kentuckians for Energy Democracy.

Building new natural gas plants will not prepare our city for the future. I have worked in the energy industry for several years now and I know first hand how bad volatile natural gas prices are for business. The price has swung between \$10 per dekatherm and \$3 per dekatherm just this year. It's a bad idea to rely on it just for that reason. Natural gas also pollutes the local atmosphere. Citizens of Louisville breath air polluted by pm 2.5 more than many other cities because we rely on combustion energy so much. Natural gas also frequently and invisibly leaks out of distribution lines, which makes it as big of a contributor to global warming as coal, because unburned methane is a much more potent greenhouse gas than CO2.

Our city instead needs renewable energy and we especially need energy storage from our grid. LG&E should create pumped hydro storage on the river to support investment in solar energy. Their current rate restructuring practices discourage solar energy. They consistently increase the proportion of electricity bills based on demand. Solar power is variable, so installing it almost never decreases a customer's demand charges. They know the consequences of this and yet the bill restructuring continues. Please, listen to your constituents who want solar power for their homes.

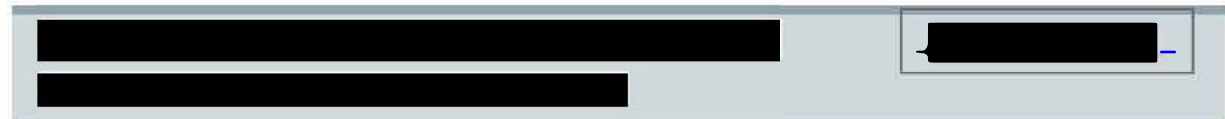

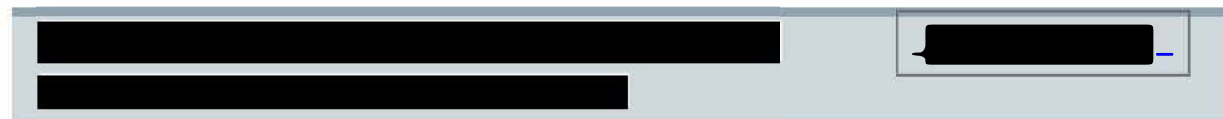
