Dear Public Service Commission,

LG&E's proposal to build new expensive, polluting gas plants is wrong in every way. It's great that old coal plants will be retired, but it doesn't make sense to sink a huge new investment into gas plants, when we should be moving away from fossil fuels. It's both financially irresponsible and harmful to the health of Kentuckians.

We should instead be expanding energy efficiency programs, rooftop solar, utility scale solar, storage, and looking at all other alternatives. We need a public commitment to ignore the companies' 1% cap on rooftop solar and to continue to support distributed resources after reaching that threshold. Rooftop solar benefits everyone, including the utility companies – for example, by decreasing demand on “critical peak summer days” – exactly the kind of days LG&E historically has asked customers to help with by volunteering for their Demand Conservation program. Dear Public Service Commission,

Thank you for ensuring that Kentuckians' voices are an important part of the regulatory process. It is clear the companies did not properly consider energy efficiency and solar as resources that could lessen our need to build new generation. They were clearly committed to building these new natural gas plants before they admitted it to the public or the PSC.

They claim that their expansion of the WECARE energy efficiency program will help low-income people. That is not true. Their changes make it easier for moderate income folks to access help-- that won't translate to helping our most vulnerable neighbors keep their heat on.

LG&E-KU Have Not Acted in Good Faith

They did not engage with their stakeholders in good faith, either with the PSC (during the Integrated Resource Plan) or with the Demand-Side Management advisory group (not having the time or a process to actually change their proposal).

LG&E-KU must be held accountable for using the proper planning processes to ensure that they are making sound decisions for the future. They knew that they wanted to build these natural gas plants before the Integrated Resource Plan was submitted but failed to include it in their 15 year plan. Shame on them.

It's Time to Invest in a Sustainable Future

Their proposals will keep Kentuckians chained to expensive fossil fuels and dirty power plants that are already obsolete, and could become stranded assets that will only add to our energy costs. It's time for the companies to invest in our homes, businesses and gathering places - not 40-year gas plants that threaten our very existence.

I want to leave a livable planet behind for my son and any future generations, the time to act was 40 years ago, but there is no time like the present to finally start to make the right decisions.

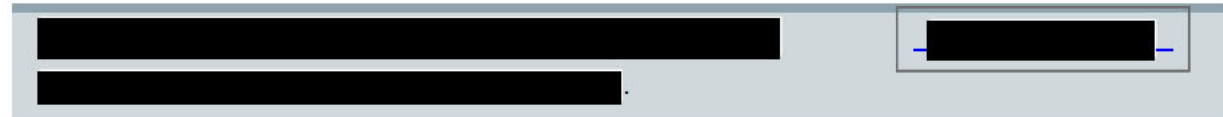
