Comments: Information is circulating that the interpleaders in this case have signed a settlement stipulation. Please be advised that myself with many others do not consider any of these interpleaders in any way our consented agents. As you well know KPCO already has one of if not the highest rates in the state. Below find a comparison of KPCO base rates with those of Cumberland Valley Electric who serves a portion of Letcher County in which I live. The customer service charges being very similar \$17.50 and \$17.62 respectively. Note however that KPCO current per KWH rate of .10799 is 27% higher than Cumberland Valley's per KWH rate of .0815. It is very hard for us to accept any rate increase when we are already paying so much more than our neighbors. Perhaps the PSC should consider some way of converting the KPCO service area into a rural cooperative(s), or at least extending the service areas of some of the existing cooperatives.

Public Comment in KPC General Adjustment of Rates Case #2023-00159

Kentuckians need electric utilities which prioritize affordable energy, energy efficiency, and grid resiliency through utility-scale solar, distributed generation and battery storage. Unfortunately, the existing business model is oftentimes at odds with those needs. That is why we rely on the Public Service Commission to ensure that our utilities are headed in the right direction and making the choices that are best for customers and our energy system both now and in the long-term. Many Kentuckians already struggle to pay our electric bills and we cannot afford to pay for utilities' bad business decisions.

Utilities, like Kentucky Power, could be investing directly in us through energy efficiency, demand-side management and inclusive financing. They could be exploring innovative ways to lower demand and our power bills through new technology, like virtual power plants. And they could be looking internally at where they can cut costs before asking hardworking Kentuckians to scrape up more money for their electric bills at a time when the cost of living is skyrocketing, and wages are stagnant.

Kentucky Power is claiming that increased rates are needed due to a declining customer base and the costs of extreme weather events.

But ratepayers across eastern Kentucky are already far more financially stressed than Kentucky Power!

Nearly 190,000 termination notices were sent to customers between July 2022 and June 2023, and more than 6000 customers were disconnected from their power because they could not afford their bills.

KPC doesn't even have direct investors, as they are wholly owned by American Electric Power, which is in great financial shape. Even though AEP's net income for the twelve months ending in June 2023 declined by 22.84%, their net profit *increased* by 1.96% over the same time frame. (**Total: \$12.307 billion.**)¹

Furthermore, many of KY Power's financial stressors are going away soon. They have divested from the Mitchell plant, and they have been granted permission to pursue securitization for costs associated with the Rockport and Big Sandy generation units. Expert witnesses for the Attorney General, the Kentucky Industrial Utility Customers (KIUC), and the Joint Intervenors agree that KPC does not need and should not receive the full proposed rate increase. The expert witness for the Joint Intervenors took particular issue with the Company's proposed increase to its return on equity, which he recommended leaving unchanged. (Tyler Coming's testimony on behalf of Joint Intervenors Mountain Association, Appalachian Citizens' Law Center, Kentuckians for the Commonwealth, and Kentucky Solar Energy Society.)²

In fact, KPC's customers are already paying the highest average residential bills in the state (KPC's average of \$187/month³ is more than 50% higher than the state average of \$117)⁴, and suffering some of the highest energy burdens in the nation. For example, there are 2780 households in Pike County alone earning less than 50% of the federal poverty level, with an average energy burden of 32.2%.⁵ Those



households have energy bills that exceed affordable levels by an average dollar amount of \$1354 per household in 2022, pushing the total collective affordability gap to \$5,920,360 - again, just in Pike County! KPC customers deserve better and need tools to respond to high bills - particularly equitable access to utility programs for efficiency and rooftop solar in their homes and businesses.

Instead of raising rates, KPC could and should invest in energy efficiency programs that both lower customers' bills and decrease the need for expensive new power plants. They should then build on those programs by implementing a tariff⁶ for inclusive utility investments⁷ alongside their DSM offerings, to make sure that every ratepayer can access their programs and become an immediate candidate for clean energy retrofits that can lower costs for the entire rate base⁸ when implemented at scale. (Josh Bill's testimony on behalf of Joint Intervenors Mountain Association, Appalachian Citizens' Law Center, Kentuckians for the Commonwealth, and Kentucky Solar Energy Society.⁹)

KPC's customers need warm, safe, resilient homes with affordable electric bills. Raising rates will do nothing to ensure that Kentucky Power customers have more reliable electricity if we allow KPC and their parent company AEP to continue to pass along the costs of their bad decisions and poor planning. The commission should not allow the company to increase rates and instead should ensure that KPC makes smart, long-term plans for the future including energy efficiency programs that benefit low-income customers and distributed renewable energy resources (like rooftop solar and battery storage for critical facilities) that will make the grid more reliable and resilient.

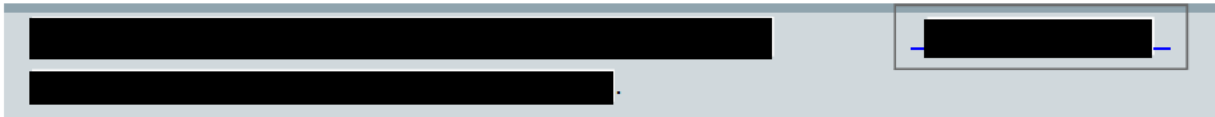
