Case #2023-00159 KY Power Rate Case, please do NOT grant the rate increase. While there are programs to help low income families with their bills and/or energy efficient upgrades, many do not qualify for those programs because of income ranges to meet the program. My family is one of those. Both my husband and I work full time jobs and are blessed to have what used to be considered good paying jobs. With groceries and gas increases last thing we can afford is an electric bill increase. We've been on the budget plan for several years now. My monthly electric bill, on the budget plan, ranges from \$450 to \$500 a month! Our summer energy bill would be \$200 and our winter bills would be \$800 or more without the budget. Please consider families that struggle but do not meet income requirements for program assistance. We cannot afford a rate increase.
