ORDER

On October 30, 2023, the Commission issued a final Order in this matter. On October 31, 2023, Green River Valley Water District (Green River Valley District) filed a motion to request the Commission amend its October 30, 2023 Order to correct certain typographical or mathematical errors. Green River Valley District requested that the tap fee for 5/8-inch x 3/4-inch meter of \$1,299 listed in Appendix B be corrected to reflect \$1,227, consistent with the Commission’s finding regarding the fee set forth on page 14. Green River Valley District also requested that the minimum bill for a 1.5-inch meter listed as \$70.37 in Appendix B be corrected to reflect the correct calculation for the minimum bill for a 1.5-inch meter of \$80.99.

Having reviewed the record, the Commission finds that the October 30, 2023 Order did contain inadvertent typographical errors for which Green River Valley District requested an amendment, and Appendix B to the October 30, 2023 Order should be amended to reflect a tap fee for 5/8-inch x 3/4-inch meter of \$1,227 and using the cost-of-service study provided in the application, a minimum bill for a 1.5-inch meter of \$81.40.

The Commission HEREBY ORDERS, *nunc pro tunc*, that:

1. Green River Valley District’s motion is granted.


2. Appendix B to the Commission's October 30, 2023 Order is amended to reflect a tap fee for 5/8-inch x 3/4-inch meter of \$1,227 and a minimum bill for a 1.5-inch meter of \$81.40.

3. All other provisions of the Commission's October 30, 2023 Order that are not in conflict with the provisions of this Order shall remain in effect.


4. This case is closed and removed from the Commission's docket.
