ORDER

On October 30, 2023, the Commission issued a final Order in this matter. On November 13, 2023, Green River Valley Water District (Green River Valley District) filed a second motion to request the Commission amend its October 30, 2023 Order to correct certain typographical errors.<sup>1</sup>

In the October 30, 2023 Order, the Commission noted that Green River Valley's cost of service study (COSS) was used to calculate the retail rates and wholesale rate. In Green River Valley District's November 13, 2023 motion, it pointed out that, with the exception of the 5/8- x 3/4-inch meter classification, the volumes for each meter service size listed in Appendix B differed from those currently in Green River Valley's tariff and those proposed in Green River Valley's COSS, and requested that Appendix B to the October 30, 2023 Order be amended to reflect the rate schedule for all meter classifications as reflected in the COSS. Green River Valley requested to amend the rate schedule to be effective retroactively as of October 30, 2023.

<sup>1</sup> Order (Ky. PSC Nov. 13, 2023), granted Green River Valley's October 31, 2023 motion for an amendment to Appendix B of the October 30, 2023 Order to reflect a tap fee for the 5/8 x 3/4-inch meter of \$1,227 and a minimum bill for a 1.5-inch meter of \$80.99, consistent with the COSS.

Upon review, an error was also found in the Commission's November 13, 2023 Order, in which the minimum bill for a 1.5-inch meter of \$80.99, was inadvertently changed to \$81.40.

Having reviewed the record, the Commission finds that the October 30, 2023 Order did contain inadvertent typographical errors for which Green River Valley District requested an amendment, and Appendix B to the Commission's October 30, 2023 Order, as previously amended by Commission Order on November 13, 2023, should be amended to reflect the rate schedule for all meter classifications, other than 5/8- x 3/4-inch meter, to match the rate schedule provided in Green River Valley's COSS after the adjustment of the nonrecurring charges, and the charge for the minimum bill for a 1.5-inch meter should be corrected to reflect \$80.99.


Finding that the October 30, 2023 Order shall be amended, the Commission HEREBY ORDERS, *nunc pro tunc*, that:

1. Green River Valley District's motion is granted.
2. Appendix B to the Commission's October 30, 2023 Order, as previously amended by Commission Order on November 13, 2023, is further amended, as attached, to correct the rate schedule for all meter classifications except 5/8 x 3/4-inch meter and the minimum bill for a 1.5-inch meter is revised to reflect the requested rate of \$80.99. This rate schedule and the rates provided in the attached Appendix B shall be effective retroactively beginning October 30, 2023.
3. All other provisions of the Commission's October 30, 2023 Order, as amended by the November 13, 2023 Order, that are not in conflict with the terms of this Order shall remain in effect.

4. This case is closed and removed from the Commission's docket.
