ORDER


On September 12, 2025, the Commission issued its order stating that Commission Staff's Report (Staff Report) in this proceeding represented the final substantive action. As part of the Order, the Commission permitted parties to file comments regarding Commission Staff's Report on or before October 15, 2025. The Order also permitted Kentucky Power Company (Kentucky Power) to file comments in response to parties' comments and the Staff Report on or before November 14, 2025.

As the deadline for comments and responses has passed, the Commission finds that this case shall be closed. Consistent with the Commission's May 27, 2025, Order in this case, Kentucky Power shall file its next IRP no later than March 20, 2027.

1. Kentucky Power shall file its next IRP no later than March 20, 2027.
2. This case is closed and removed from the Commission's docket.
