### <u>O R D E R</u>

On May 2, 2023, the Commission entered an Order establishing a procedural schedule.<sup>1</sup> On May 26, 2023, the city of Louisa (Louisa) filed a motion for an extension of time to respond to Commission Staff's First Request for Information (Staff's First Request). The motion stated that the Louisa would not be able to provide all the information by June 1, 2023, and requested an extension until June 12, 2023.<sup>2</sup>

Having reviewed the record and being otherwise sufficiently advised, the Commission finds that the Louisa's motion for an extension of time to respond to Staff's First Request until June 12, 2023, should be granted. The Commission, on its own motion, finds that the procedural schedule entered in the May 2, 2023 Order should be amended to allow Commission Staff sufficient time to complete its review and prepare the Commission Staff's Report.

IT IS THEREFORE ORDERED that:

1. Louisa's motion for an extension of time is granted.

2. Louisa shall file its responses to Commission's Staff's First Request for Information no later than June 12, 2023.

3. The amended procedural schedule set forth in the Appendix to this Order shall be followed.

4. All remaining provisions of the May 2, 2023 procedural schedule not in conflict with this Order remain in effect.

5. The Commission does not look favorably upon motions for continuance. Accordingly, future motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of good cause.
