ORDER

On December 8, 2023, Kentucky Power Company (Kentucky Power) filed a motion pursuant to 807 KAR 5:001, Section 13, and KRS 61.878 requesting that the Commission grant confidential treatment for certain information contained in stenographic transcripts of testimony given during confidential sessions of the hearing in this matter on November 28, 2023, and November 30, 2023.

<u>Testimony Regarding the Response to Commission Staff's First Request for</u> <u>Information (Staff's First Request), Item 33, Attachment 1</u>

Kentucky Power requested confidential treatment for five years for information contained in stenographic transcripts of testimony of Brian K. West, Andrew R. Carlin, and Katharine I. Walsh regarding information contained in Attachment 1 to Kentucky Power's response to Staff's First Request, Item 33, (Attachment 1) pursuant to KRS 61.878(1)(a), KRS 61.878(1)(c)(1), KRS 61.878(1)(k), and 17 C.F.R. § 240.10b-5

given during confidential session of the hearing in this matter on November 28, 2023, and November 30, 2023.

The testimony regarding Attachment 1 includes non-public compensation information for Kentucky Power's executive officers and other employees. In support of its motion, Kentucky Power stated it is required to maintain the confidentiality of the executive officer information under SEC regulation, 17 C.F.R. § 240.10b-5, until the information is included in publicly filed documents.¹ According to the motion, review of this information on a confidential basis could subject the reviewer to confidentiality and insider information obligations and restrictions under SEC rules.² Kentucky Power argued that this information is highly sensitive, even internally within Kentucky Power, and is only available on a need-to-know basis.³ As noted above, in an October 2, 2023 Order, the Commission granted confidential treatment for non-public executive officer compensation information until the information was publicly filed by the SEC.⁴

The Commission granted confidential treatment for non-executive officer employee compensation pursuant to KRS 61.878(1)(a) and (c).⁵ Attachment 1 was discussed during confidential session, and to the extent that there may have been conversations concerning non-executive officer employee compensation, Kentucky Power requested confidential treatment for five years.⁶ Kentucky Power argued that

public disclosure of this personal information is likely to result in increased costs and a loss of negotiating ability for Kentucky Power and increases the risk of a higher cost of service resulting from greater employee compensation demands and higher costs to recruit and retain skilled employees and managers.⁷ After five years the labor market will have changed sufficiently and there will no longer be any competitive advantage to gain from the information.

Having considered the motion and the material at issue, the Commission finds that the testimony regarding information contained in Attachment 1 is generally recognized as confidential or proprietary to the extent discussed below. The disclosure of executive salary information as it relates to SEC filings is generally considered confidential until public disclosure is made by the company, and as such; confidential treatment is granted pursuant to KRS 61.878(1)(k) until the public filing is made with the SEC. To the extent the non-executive salaries listed in Attachment 1 were discussed, the information meets the criteria for confidential treatment and should be exempted from public disclosure for five years pursuant to 807 KAR 5:001, Section 13, KRS 61.878(1)(a), and KRS 61.878(1)(c)(1) consistent with prior cases involving salary and compensation information.⁸

<u>Testimony Regarding the Response to All-Source Request for Proposals</u>

Kentucky Power sought confidential treatment indefinitely for stenographic transcripts of testimony of Alex E. Vaughan regarding high-level details of the responses to Kentucky Power's All-Source Request for Proposals (RFP) on November 30, 2023, pursuant to KRS 61.878(1)(c)(1).

In support of its motion, Kentucky Power argued that the high-level details of the responses to the All-Source RFP are highly confidential and public disclosure of their existence or non-existence would cause competitive injury to Kentucky Power.⁹ The information discussed concerned responses to an All-Source RFP for generation resources, which were provided to the Kentucky Power on a confidential basis by the respondents. According to the motion, the information discussed also provided insight into the manner by which Kentucky Power evaluates bids in response to the RFP.¹⁰ Kentucky Power argued that failure to maintain this information as confidential may have a chilling effect on the willingness of future bidders to submit responses to Kentucky Power RFPs.¹¹ In addition, if offers are less competitive than they otherwise would be, Kentucky Power and its customers may be harmed through higher costs than would otherwise be incurred.

Having considered the motion and the material at issue, the Commission finds that the discussion regarding the All-Source RFP is generally recognized as confidential or proprietary. At the time, Kentucky Power had not selected a winning bid nor finished

evaluating the applicants. As such, disclosure of the information would disadvantage Kentucky Power in future RFPs as well as allow applicants to possibly manipulate the process should no vendor be selected and therefore meets the criteria for confidential treatment and should be exempted from public disclosure pursuant to 807 KAR 5:001, Section 13, and KRS 61.878(1)(c)(1).

IT IS THEREFORE ORDERED that:

- 1. Kentucky Power's December 8, 2023 motion for confidential treatment is granted.
- 2. The testimony contained in stenographic transcripts of Brian K. West, Andrew R. Carlin, and Katharine I. Walsh given on November 28, 2023 regarding executive officer salary information contained in Attachment 1 to Kentucky Power's response to Staff's First Request, Item 33, granted confidential treatment by this Order, shall not be placed in the public record or made available for public inspection until the information is publicly filed with the SEC, or until further Order of this Commission.
- 3. The testimony contained in stenographic transcripts of Brian K. West, Andrew R. Carlin, and Katharine I. Walsh given on November 28, 2023, and November 30, 2023, regarding the remainder of the employee salaries contained in Attachment 1 to Kentucky Power's response to Staff's First Request, Item 33, granted confidential treatment by this Order, shall not be placed in the public record or made available for public inspection for five years, or until further Order of this Commission.
- 4. The testimony contained in stenographic transcripts of Alex E. Vaughan regarding high-level detail of the responses to Kentucky Power's All-Source Request for Proposals, granted confidential treatment by this Order, shall not be placed in the public

record or made available for public inspection for an indefinite period, or until further Order of this Commission.

- 5. Use of the designated material granted confidential treatment by this Order in any Commission proceeding shall comply with 807 KAR 5:001, Section 13(9).
- 6. If the designated material granted confidential treatment by this Order becomes publicly available or no longer qualifies for confidential treatment, Kentucky Power shall inform the Commission and file with the Commission an unredacted copy of the designated material.
- 7. If a nonparty to this proceeding requests to inspect the material granted confidential treatment by this Order and the period during which the material has been granted confidential treatment has not expired, Kentucky Power shall have 30 days from receipt of written notice of the request to demonstrate that the material still falls within the exclusions from disclosure requirements established in KRS 61.878. If Kentucky Power is unable to make such demonstration, the requested material shall be made available for inspection. Otherwise, the Commission shall deny the request for inspection.
- 8. The Commission shall not make the requested material available for inspection for 30 days from the date of service of an Order finding that the material no longer qualifies for confidential treatment in order to allow Kentucky Power to seek a remedy afforded by law.
