ORDER

The Commission, on its own motion, finds that an Order addressing the logistics of the hearing beginning on November 28, 2023, and continuing upon verbal announcement by the presiding officer until conclusion, is necessary given the number of parties to and the complexity of this case.

Due to spacing issues in the Richard Raff Hearing Room, and the number of parties, there shall be a schedule for attorney seating at counsel table. The Applicant will be allowed two seats at counsel table. The Attorney General, by and through the Office of Rate Intervention (Attorney General) and Kentucky Industrial Utility Customers (KIUC) will be permitted one seat each at counsel table. All other intervenors will be permitted to rotate, utilizing the final seat at counsel table, when questioning witnesses.

All parties shall submit a list of witnesses expected to testify at the hearing on or before November 20, 2023. Unless otherwise ordered by the Commission, all witnesses who have provided written testimony, responded to data requests or request for

information, or have otherwise filed oaths or affirmations in this matter are expected to call to testify at the hearing. The parties should ensure, during the hearing, they have 20 copies of each potential exhibit to tender to other parties, Commission Staff, and Commissioners. The parties shall provide copies of any documents anticipated to be introduced as exhibits at the hearing to Commission Staff by electronic mail on or before November 26, 2023. The order for witness testimony will be the Applicant; the Attorney General; KIUC; Wal-Mart Inc. (Walmart); SWVA Kentucky, LLC (SWVA); and Mountain Association (MA), Appalachian Citizens Law Center (ACLC), Kentuckians for the Commonwealth (KFTC), and the Kentucky Solar Energy Society (KYSES) (collectively, Joint Intervenors) unless otherwise dictated by Commission Order. The order for cross-examination shall be the Attorney General, KIUC, Walmart, SWVA, Joint Intervenors, and Commission Staff.

IT IS THEREFORE ORDERED that:

1. All parties shall submit a list of witnesses expected to testify at the hearing, and the order in which they will be called, on or before November 20, 2023.
2. All parties shall submit any exhibits anticipated to be used at the hearing to Commission Staff on or before November 26, 2023.
3. The order for witnesses shall be the Applicant, the Attorney General, KIUC, Walmart, SWVA, and Joint Intervenors.
4. The order for cross-examination shall be the Attorney General, KIUC, Walmart, SWVA, Joint Intervenors, and Commission Staff.
