## <u>O R D E R</u>

On July 14, 2023, Kentucky Power Company (Kentucky Power) filed an application for a securitization financing order pursuant to KRS 278.672.<sup>1</sup> Pursuant to KRS 278.674(3)(a), the costs associated with retaining counsel or financial advisers shall be paid by the applicant and be included as financial costs in the securitization surcharge.<sup>2</sup> On August 2, 2023, the Commission entered an Order dictating the process by which Kentucky Power will remit payment for the costs associated with the Commission's advisers in this case.<sup>3</sup>

The Commission finds that Saber Partners, LLC (Saber) submitted an invoice for consulting services for February 1, 2024, through February 29, 2024. IT IS THEREFORE ORDERED that:

1. Kentucky Power shall remit payment to the Commission for Saber's invoices rendered as a consultant to the Commission.

2. Kentucky Power shall remit payment within 30 days of the date of service of this Order.

3. The payment shall be a cashier's check or money order made payable to the Kentucky State Treasurer that is delivered or postmarked as mailed to the Office of General Counsel, Public Service Commission, P.O. Box 615, Frankfort, Kentucky 40602-0615, before the deadline.
