## COMMISSION STAFF'S THIRD REQUEST FOR INFORMATION TO ALLEN COUNTY WATER DISTRICT

Allen County Water District (Allen District), pursuant to 807 KAR 5:001, shall file with the Commission an electronic version of the following information. The information requested is due on December 12, 2025. The Commission directs Allen District to the Commission's July 22, 2021 Order in Case No. 2020-00085<sup>1</sup> regarding filings with the Commission. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked.

Each response shall include the question to which the response is made and shall include the name of the witness responsible for responding to the questions related to the information provided. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the

response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Allen District shall make timely amendment to any prior response if Allen District obtains information that indicates the response was incorrect or incomplete when made or, though correct or complete when made, is now incorrect or incomplete in any material respect.

For any request to which Allen District fails or refuses to furnish all or part of the requested information, Allen District shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied and scanned material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations. When filing a paper containing personal information, Allen District shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

- 1. Refer to Allen District's motion to amend [Qualified Infrastructure Improvement Plan] QIIP and for authority to expend water surcharge proceeds filed September 3, 2025. For each item requested in the Equipment Purchase Plan:
- a. Provide a detailed explanation of why Allen District needs the item and how the item will help reduce water loss.

b. State whether the item is replacing a current item that Allen District

owns. If so, state how old the item is and why it needs to be replaced.

2. State whether Allen District currently owns a vacuum excavator. If so,

provide the following:

a. The model year and state whether the new vacuum excavator would

be in addition to or would act as a replacement.

b. The remaining useful life on any currently owned vacuum excavator.

3. State whether Allen District currently owns a mini excavator. If so, provide

the following:

a. The model year and state whether the new mini excavator would be

in addition to or would act as a replacement.

b. Provide the remaining useful life on any currently owned mini

excavator.

4. State whether Allen District currently owns a truck(s) that can pull the

vacuum excavator and mini excavator. Include in the response, whether Allen District

also owns a trailer for both excavators.
