ORDER

On September 18, 2024, the Commission issued a final rehearing Order establishing, in part, a revised revenue requirement and set forth adjusted rates for Shelby Energy Cooperative (Shelby Energy). During the pendency of rehearing in this matter, the Commission issued a final rehearing Order in Case No. 2023-00014<sup>1</sup> approving East Kentucky Power Cooperative, Inc.'s (EKPC) member cooperatives increase to their base energy rates on or after September 1, 2024, to reflect the reestablishment of fuel base costs for EKPC, as approved in Case No. 2023-00009,<sup>2</sup> adjusted for line loss.

The rates included as Appendix B to the September 18, 2024, final rehearing Order did not include the fuel adjustment clause roll-in for Shelby Energy's base energy rates as approved by the Commission on August 30, 2024, in Case No. 2023-00014. Thus,

the Commission finds the omission of the increase to the base fuel cost to be a clerical error that should be corrected by an adjustment to the rates of the rehearing Order issued in 2023-00213 to reflect the increase to the base fuel cost.


The Commission HEREBY ORDERS, *nunc pro tunc*, that:

1. The energy rate in Appendix B, Residential Service of \$0.09322 per kWh is stricken and replaced with \$0.10482 per kWh.
2. The energy rate in Appendix B, Prepay Service of \$0.09321 per kWh is stricken and replaced with \$0.10481 per kWh.
3. The energy rate in Appendix B, General Service of \$0.09189 per kWh is stricken and replaced with \$0.10349 per kWh.
4. The tariff sheets filed pursuant to the Order on September 18, 2024, shall reflect the corrected rates set forth in this Order.
5. All provisions of the September 18, 2024 Order that are not in conflict with the terms of this Order shall remain in effect.
6. This case is closed and removed from the Commission's docket.
