ORDER

On June 16, 2023, Lindsey Enterprises, LLC (Lindsey Enterprises) filed, through the Commission’s electronic Tariff Filing System, its tariff to establish initial rates, rules, and regulations pursuant to KRS 278.485 and 807 KAR 5:026, which govern gathering systems that provide service to retail customers who tap onto farm tap systems. On July 7, 2023, the tariff filing was suspended pursuant to KRS 278.190(2) for five months pending an investigation to determine the reasonableness of the proposed tariff and a procedural schedule was established.<sup>1</sup> On July 27, 2023, the Commission issued Commission Staff’s First Request for Information (Staff’s First Request) to Lindsey Enterprises, which required Lindsey Enterprises to file responses to Staff’s First Request with the Commission no later than August 11, 2023.<sup>2</sup> On August 7, 2023, Lindsey Enterprises filed a motion requesting an extension of time (motion) for an additional two weeks, up to and including, August 25, 2023, to submit its response to Staff’s First Request.

Lindsey Enterprises stated in its motion that it has been strained due to the short turnaround in the requests and summer travel schedules, in addition to ensuring that all responsive documents conform to the Commission's filing requirements, and therefore requests an extension no later than August 25, 2023, to file its responses to Staff's First Request.

The Commission, having considered Lindsey Enterprises' motion, finds that good cause exists to grant an extension no later than August 25, 2023, to file its responses to Staff's First Request. The Commission also finds that an amended procedural schedule should be established. The amended procedural schedule is attached as an Appendix to this Order.

IT IS THEREFORE ORDERED that:

1. Lindsey Enterprises' motion for an extension of time is granted.
2. Lindsey Enterprises shall file its responses to Staff's First Request no later than August 25, 2023.
3. The previous procedural schedule entered on July 7, 2023, is amended as set forth in the Appendix to this Order and shall be followed.
4. The Commission does not look favorably upon motions for continuance. Accordingly, future motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of good cause.
